Nationwide the Proposed FY 2007 Budget Stiffs Fire Stations By \$707 Million; New York Stations Could Lose \$31 Million

New York Fire Fighters In Almost 700 Municipalities Have Received Over \$102 Million Since 2001

The proposed federal budget for Fiscal Year 2007 shortchanges local fire departments nationwide \$707 million that was promised by Congress. Since the Assistance to Firefighters Grant Program began in 2001, New York State fire departments have received more than \$100 million from the program; these new cuts could shortchange upstate New York fire departments by \$31 million next year. Senator Schumer is working to restore this critical funding for fire departments by seeking to increase the allocation to \$1 billion nationwide. **Below is a county-by-county breakdown of how much fire departments in each county have previously received from the program and how much the proposed cuts could impact each county next year.**
