Schumer Study: New Savings Plan Will Give New Yorkers Multi-Million Dollar Head Start In Saving For College And Retirement

Today household savings in America is at an all time low, which is bad for kids, families, and future retirements. To tackle this problem earlier, and encourage financial literacy over a lifetime, the ASPIRE Act (America Saving for Personal Investment, Retirement, and Education) will establish a KIDS account for every New Yorker.

The Schumer study estimates that over 1 million New York kids could earn over \$500 million in initial \$500 government contribution to jump start their college and retirement savings. Because the accounts are structured to give up to a \$500 yearly match to families who earn the median income (\$42,000) or less, over 400,000 Upstate New York kids could earn thousands more in government matching contributions before their 18th birthdays.

In the Capital Region, over **127,000 children** could start life with a **\$64 million** jump start on saving for college and retirement. An additional 49,000 children could put away up to \$1,000 a year including a \$500 government match.
