Fort Drum	The Fort Drum area of New York State (Jefferson, Lewis, and St. Lawrence Counties) is quite rural encompassing many small villages, townships and the City of Watertown the largest, most northern city in New York State with a population of 25,622. Businesses and organizations are dispersed throughout this rural, agricultural and forested landscape. Fort Drum is the largest single site employer in New York providing 18,910 jobs; Protecting these jobs and enhancing the military mission is vitally important to New York State.; At the end of FFY 2020, the assigned Soldier population at Fort Drum was 14,998, with on post civilian employment at 3,912;Fort Drum combined annual direct payroll was \$1.17 billion. The total economic impact for Fort Drum operations including payroll for FY 2020 was \$1.43 billion. The privately-owned on post family housing contributes \$8.6 million annually to the local economy. Our local schools and hospitals provide vital services to our entire military community. More than \$41 million in Federal Impact Aid ;is received annually to support educating military children within our local schools.
