Schumer Study: How Many New York Reservists Lose Income At Home While Fighting Terror Abroad?

While thousands of brave New Yorkers face America's enemies abroad, the hidden "shame of the service" is that many of these soldiers and their families suffer financial hardship at home. To make sure that soldiers don't sacrifice their livelihoods at home when risking their lives abroad, Senator Schumer has proposed a 50% tax credit for employers of reservists serving overseas. This tax credit would make it easier for employers to keep paying the salaries of soldiers and would keep the troops' families solvent on the home front.

Recent data indicates over 7,400 New Yorkers serve on active duty in the National Guard or Reserves. A recent report by the non-partisan, independent Government Accountability Office indicates that 41% of those reservists may lose significant income while serving their country in Iraq or Afghanistan. Senator Schumer released a report today detailing the number of reservists serving from every county in New York State, and the estimated number of reservists losing income.

The Schumer study calculated the estimated number of reservists who would be helped by the Schumer tax credit based on data supplied by the Pentagon's Defense Manpower Institute, and reports by the independent, non-partisan Government Accountability Office. The number of reservists is as of December 1, 2004.

The following report details the numbers of county-by-county called up reservists and the estimated number of reservists losing income due to service overseas.

Capital Region: Currently there are 792 Capital Region reservists serving their country overseas on active duty. An estimated 325 of those reservists' families lose income as a result of their service, and could be helped by the Schumer tax credit.
